Mr. President,
Mrs President,

I inform you for the preparation of the university competition programmed in VOLOS (GREECE) from June 27th to July 1st and mainly, on three points:

1. Endorsement of FISU

You can find after this letter the official communication of FISU for endorsement of our competition 2016 in VOLOS. In letter, the name of Alexandropoulis appears. Just because when we send request, the place of Volos was not decided. The information to change is sent and in process. The most important for us is this agreement.

2. Statement of participation

Actually, 22 countries are recorded on www.cmasoffice.org.

The implication of all is necessary for the result of this common project even if you take part only with one female athlete and a male athlete. Most important is the level of representation of the number of countries.

For the recording of your participation, you must do it like usually on www.cmasoffice.org.

3. Precise details concerning the participation of the athletes

I recall you the specific rules of participation. Here are the contents:

- *Eligible to participate at this Championship are the university teams of National Federations, affiliated to CMAS as following:*
 - a) *Students who are currently officially registered as proceeding towards a degree or diploma at a university or similar institute whose status is recognised by the appropriate national academic authority of their country;*
 - b) *Former students of the institutions mentioned in a) who have obtained their academic degree or diploma in the year preceding the event;*
- *All competitors must satisfy the following conditions:*
 - a) *Be a national of the country they represent (nationality);*
 - b) *Be at least 17 and less than 28 years of age on January 1st in the year of the event.*

Individual dossier to submit on arrival

The dossier must include:

- *If a student*
 - a) *a document proving that s/he has satisfied the conditions normally required in his/her country for entrance to a university or similar institute;*
 - b) *Student card or certificate from the appropriate national academic authority certifying that the competitor is currently officially registered as proceeding towards a degree or diploma at a university or similar institute whose status is recognized by the appropriate national academic authority of their country.*
- *If a former student: Proof of the date s/he obtained his/her final academic degree or diploma;*
