Date: 23-30 August

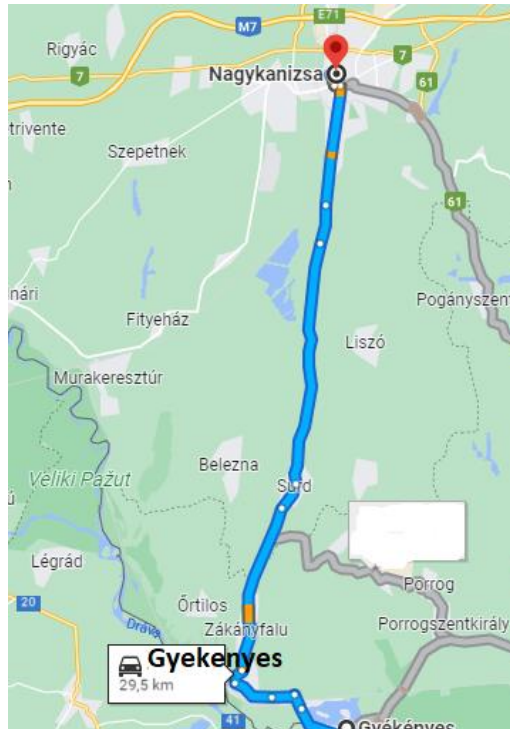
Location: Gyékényes-Hungary

Lake of Gyékényes is located at the south – western part of Hungary, approx 235 km far from Budapest, close to the Hungarian – Croatian border. For precise location see the map below. The average depth is about 3 – 15 m, water temperature is 20 – 22 °C, and usual visibility is about 3-4 m.

Conditions of participation:

Only CMAS-registered underwater orienteering federations are allowed to participate in the competition, provided they accept the rules in effect and the relevant CMAS regulations.

Each national federation will be represented by a junior team consisting of

- 1 team manager,
- 5 female juniors,
- 5 male juniors
- 1 trainer

Three men and three women respectively can compete for each nation in the individual events and additional 1 – 1 team in team competition and 2 – 2 team MONK event. During international championships mixed teams (men and women) are not allowed to compete in the team event. It is allowed to fill up a team with Juniors should a team not have enough competitors.

1. Application:

The preliminary entry form (Annex 1) must be sent back to Organisers and CMAS until **30th June 2026**.

Final entry form (Annex 2) must be sent back to Organisers and CMAS until **15th July 2026**.

End of registration: 15th July 2026

Teams should present the following documents at arriving:

Bank note of payment of participation fee and CMAS fee.

CMAS fee must be paid directly to CMAS account until 15th July 2026.

Competitors CMAS licence / 2026

Registration for the 2026 European Championships will take place on the CMAS portal <https://portal.cmas.org/login>

The portal for registering for the European Championship is available on the CMAS homepage.

It is required at CMAS Portal to pay the athlete license for participation before it is available to add the participants to competition.

This cost is not included in the participation fee. These costs must be paid to the CMAS directly through CMAS Portal.

Fees: EUR 850 per adult competitor

(includes EUR 700 – participation fee + EUR 150 organizing fee)
Accommodation with meals, Closing Party

EUR 800 per youth competitor

(includes EUR 650 – participation fee + EUR 150 organizing fee)
Accommodation with meals, Closing Party

EUR 700 per other person

Accommodation with meals, Closing Party

EUR 100 protest fee

Method of payment is bank transfer. Organisers should be informed at info@buvar.hu until 30th June 2026. In that case a proforma invoice would be issued and sent to the payee, so safe payment can be conducted.

Note: 50% Participation and organization fees must be paid until **15th July 2026** to the competition bank account.

If these fee are paid after **15th July 2026** then 10% surcharge are applied.

Organizing fee contains:

- Organisation related cost of the competition
- Administration
- Bottle filling
- Doping control (H)

Participation fee contains:

- Full board accommodation (meal 3 times a day, mineral water at meals)
- Opening and closing ceremonies
- Presents
- Closing party

Participation fee depending on the date of payment:

Fee for the closing party (for guests with no participation fee paid) 40€ / person

2. Accommodation:

Apartment house^{**}: near to the lake, about 300-800m far from competition area.
(limited capacity available)

If you wish to arrive few days earlier training camp is available.

Prior to 23 August training costs 40 €/day/competitor (including bottle filling). Please indicate your participation request until 30th June.

We can provide airport transfer for teams from Budapest to Gyékényes.

Cost is subject to the number of people.

We can only assure the transfer fee for those teams who send back the Final Entry until the deadline of 30th June.

3. Bottle filling:

- Only organizers are in charge of bottle filling. Maximum filling pressure is 20Mpa (200 bar). Connection possibilities are according to INT and DIN standard. For other extensions please bring your own adapters. Only cylinders with a valid DIN/EN certificate will be filled.
- All participating countries are responsible for adhering to their national rules regarding compressed air diving devices.

- All devices will be checked by the Hungarian authorities (MBSZ) before the start of the competition.

4. Additional information:

- ✓ Events are held according to the enclosed Programme list.
- ✓ Final results, prizes and daily programmes are provided according to the valid CMAS rules.
- ✓ International Jury is set according to CMAS rules.
- ✓ In case of a protest, the Technical Delegate is responsible for handling the issue in accordance with the applicable rules.
- ✓ The Organising Committee appoints the Team of Judges.
- ✓ Protest can be submitted according to CMAS rules. Protest fee is 100 €.
- ✓ Teams arriving by bus or car should get in touch with the organizers first for registration and other information.
- ✓ Organisers ask all teams to bring two national flags (each 2m X 1m) and the national anthem on pendrive.
- ✓ The competition will be organised according to the current CMAS rules.
- ✓ The competitors themselves are responsible for the proper condition of their equipment.
- ✓ Every athlete must have a valid CMAS license and a medical certificate not older than one year.
- ✓ Every athlete must have an own buoy. The buoy is marked with the flag, the name of the nation and the name of the competitor.
- ✓ The organizer declines any liability.
- ✓ All competitors take part at their own risk.
- ✓ Organisers reserve the right for any change in the programme – Participating teams will get all information about the changes in time.
