

## Dados do Município



### Município

São Francisco do Sul, or São Chico as it is affectionately known, is the owner of a privileged natural setting, as well as its peculiar history: it was discovered in 1504 by a French expedition and was the first settlement in Santa Catarina. Its territory is made up of an island and a mainland. On the island you'll find the Historic Centre, listed by the National Historical and Artistic Heritage Institute - IPHAN - with its narrow streets and charming Portuguese colonial-style houses, including the centuries-old Nossa Senhora da Graça Mother Church, and beautiful beaches, some of which have been awarded the Blue Flag label, ranging from those with open seas, favourable for surfing and sport fishing, to those with calm waters for leisure and sailing. On the mainland you'll find Vila da Glória which, with its beaches, waterfalls and mountains, is the guardian of wildlife and is part of the Great Atlantic Forest Reserve from which the unique Babitonga Bay rises, sheltering several endangered species such as the grey dolphin, the green turtle, the guará and the rare porpoises.

Surrounding this hospitable and charming territory are cultural traditions such as the Boi de Mamão, Dança do Vilão, handicrafts made from yarn and shells and generous seafood-based cuisine. These are just a few of the many reasons to visit São Francisco do Sul.

## VILA DA GLÓRIA


The name lives up to the location: on the mainland of the municipality, Vila da Glória is located in the Saí District and preserves the serenity of life amidst preserved nature and is part of the Grande Reserva Mata Atlântica project - the largest remnant of Atlantic forest on the planet. With its rich flora and fauna, waterfalls, streams, beaches and bucolic paths immersed in nature on the shores of Babitonga Bay, Santa Catarina's main estuary which, as well as its unique islands, is home to various species of birds and marine creatures such as the guará, the grey dolphin, the green turtle and the rare porpoise, whose only population of the species in the world, resident in an estuarine environment during its entire life cycle, is found here. It's no coincidence that these creatures chose the paradise called São Francisco do Sul to live in!

## > PRAIA DO FORTE



② São Francisco do Sul is the Brazilian municipality with the most Blue Flag beaches, four of them: Praia Grande and Praia do Ervino, which together have more than 20 kilometres of open sea and preserved nature; Praia da Saudade - or Prainha - synonymous with beauty, surfing and entertainment; and Praia do Forte with its calm, crystal-clear waters. As well as other stunning beaches such as Praia da Enseada, popular for its structure and leisure in calm waters; Praia de Fora (or Molhe), a charming refuge; Praia de Ubatuba and Praia de Itaguaçu, with their wide stretches of sand; Praia do Capri, a postcard in the midst of vegetation and the sea. In the Paulas neighbourhood you'll find the beaches of Ingleses, Figueira, Salão and Calixto, backwaters with their squares and welcoming views on the shores of Babitonga Bay. And on the mainland, in Vila da Glória, Praia Bonita dazzles with its bucolic atmosphere and protected Atlantic forest. All of these make São Francisco do Sul an unrivalled destination!

### > FORTE MARECHAL LUZ



With the aim of protecting the city from possible invasions, the Marechal Luz Fort began to be built in 1909, on the ruins of the old fortification that stood there, and was inaugurated in December 1915. Located on the north coast of the island, by the beach that bears its name, it is still controlled by the Brazilian Army, serving as a holiday camp for military personnel and open to the public. Its main attraction is the João Dias Hill, at the top of which is an artillery battery made up of four cannons and a small museum with military objects, maps, documents, communications equipment and other artefacts used at the time, as well as a spectacular view of the Graças archipelago, where the largest island houses a lighthouse and the entrance to Babitonga Bay. A stunning site that perfectly preserves nature and the region's military history.

### CONJUNTO PAISAGÍSTICO DOS CASARIOS E BABITONGA



Walking through the Historic Centre allows you to revisit more than 500 years of São Francisco do Sul through its narrow streets, fountains, seafront scenery of the exuberant Babitonga Bay and the various buildings of the architectural complex listed in 1987 by the National Historical and Artistic Heritage Institute - IPHAN. Most of the buildings are typical of Azorean architecture, and in some you can find walls made from materials used at the time of construction, such as mortar made from sand, shells, stones and whale oil, as well as the rammed earth technique, among other eclectic-style constructions. As well as private properties occupied for housing or commerce, the highlights include the Mother Church, the Public Market, the XXIV January Club, the National Museum of the Sea, the Ester dos Passos Rosa Cultural Centre and the ruins of the church of São José at the top of the hill in the Municipal Ecological Park.





### 6. BOATS FOR PARTICIPANTS:

- ✓ boats : 80 official boats will be available to athletes on the day of the competition. 60 for men and 20 for women.
- ✓ Spare Boats: 10 spare boats will be provided in case of any difficulties

### **TYPE OF BOATS**

- ✓ The boats provided range in size from 14 to 30 feet in length.
- ✓ Boats with engines from 40 to 300 HP, 2 and 4 stroke, with 1 and 2 engines
- ✓ Building structure, Fiber, V-bottom inflatable boats.
- Equipped with eco-sounder and GPS.
- ✓ Life-saving equipment required by the Brazilian Navy.

In Option "C", we let the NF to rent all or part of the boats and accommodation locations they prefer. Logically, we will provide a list with the telephone and email contacts of the boats and hotels already defined so that athletes do not have access difficulties.

If NFs opt for this payment method, the event organization can help bridge the gap between NF athletes and their boat rentals and accommodations.

Event organizers will cap the maximum amount charged by owners for boat rentals at 150 euros per day for athletes to explore the test area and a maximum of 400 euros for the two days of competition.

### 7. 2 - Registration Fees Table for MEN/WOMEN Competing and Reserve Athletes

- Every NF must get their own athletes Cmas Spearfishing license through Cmas Portal: CMAS Spearfishing License # for all athletes participating and potential substitutes as NF team members is mandatory for them and will be presented at the registering confirmation.
- When the NF orders a sports license, it undertakes to verify the possession of a medical certificate allowing the athlete to compete in the sport concerned.

**Payment Concept:** Registration payment for the 2025 CMAS WC Spearfishing MEN or 2025 CMAS WC Spearfishing WOMEN in Brazil – Sao Francisco do Sul. The costs of the bank transfer will be borne by the National Federation that registers.

#### 9. AUTHORIZED MATERIAL

- One or more rubber or compressed air rifles loaded solely by the athlete's muscular strength, excluding any intervention from any other external force.
- Fins, goggles, gloves, inner tube, lead belt.
- Knives, suits, watches, depth gauges.
- Lanterns
- Recoverable variable ballast, i.e. pendulum, always recovering it from the bottom.
- Depth Probes and GPS.
- Refrigerator.
- Safety vest approved by CMAS, the vest can be used in competition, but once used it is synonymous with disqualification.
- Weight Scales
- Float or Buoy
  - Mandatory use of an official buoy at least, provided by the organization during the two days
    of the event.
  - In case of loss of the official buoy, an official replacement will be requested from the organization. It is prohibited compete without buoy.

### 10. CHAMPIONSHIP DEVELOPMENT

The **2025 edition of the CMAS World Championship Spearfishing** will take place over two consecutive days of competition of five (5) hours each, in the waters of São Francisco do Sul – Brazil, scheduled the 28<sup>th</sup> and 29<sup>th</sup> November, 2025

The competition will be held in individual boats.

The zones where the Championship will be held will be divided into three (3) areas called "Competition Zones": two (2) main zones, in which the competition will be held, and one (1) reserve zone, in case adverse weather and sea conditions do not allow people and boats to operate safely in the main areas. These zones will be called Zone A, Zone B and Reserve Zone.

The zones will be the same for both men's and women's categories simultaneously.

The order of use of the competition areas will be established on the eve of each competition day, depending on sea conditions. Only the CMAS Technical Delegate and the Director of Competition may jointly decide to change the tournament zone due to adverse weather and sea conditions or any other cause of force majeure. In case of disagreement between the two, the decision of the CMAS Technical Delegate will prevail.

In case of "force majeur" or bad weather, the Organization may reduce the duration of the competition for safety reasons; in this case, to be valid for the purposes of the Championship, the competition session must last at least 2/3 of the scheduled time. The decision to completely interrupt a competition day or partially suspend the current race within a day rests with the CMAS Technical Delegate and the Competition Director . In the event of disagreement between the two, the decision of the CMAS Technical Delegate will prevail. The Championship will be considered valid if at least one valid competition day has been completed.

Competitors may only use the boats provided by the Organizing Committee or their own authorized boats at the time of registration, which will be considered official boats. During the two days of competition, only official boats and those duly authorized by the CMAS Technical Delegate, at the proposal of the organization, may stop in the competition area. All other vessels may not access this area.

Each national team will be equipped with a set of three (3) official boats. Considering that the boats can be of different sizes and powers:

- □ The available boats, except for competitors with their own boats, will be authorized by the organization, being distributed in series of three boats according to criteria of equity and correctness.
- The series of boats will be allocated by drawing lots, which will be held during the captains meeting
- ⇒ The distribution of boats assigned to competitors will be done by the team captains.

Team captains may only be on board in any of the three boats designated for their athletes, male or female. Captains may not be alone in independent boats in the competition zone.

- In the event of damaged / broken boat, the vessel must be replaced. Complaints about replacement vessels won't be accepted.
- National teams with their own boats must submit written notification at the time of registration.
   Boats may have a maximum power of 300 horsepower/CV. The stewards for these boats will be appointed by the organization.
- The CMAS Technical Delegate will select the stewards for the LOC Nation competitors from among the available stewards of the other nations.
- Each official vessel must receive the same competitor reference number. The competitors are not allowed to change boats .

In compliance with the provisions of art. 6.1.2 of the CMAS International Spearfishing Regulations, the scouting official period of the competition areas is set at fourteen (14) days before the start of the Championship: until November 26, 2025 (inclusive). During this period, it is prohibited to fish, carry spearfishing weapons on the vessel, use breathing apparatus and/or diving equipment other than freediving equipment, as well as the use of scooters or any other methods of underwater propulsion. Violation of this rule will result in exclusion from the Championship. If the infraction is committed by any member of the National Delegation , the entire team will be disqualified.

On the official days of recognition of the competition zones , the national teams will be responsible for managing the means of transport used for this purpose.

All competitors, delegation members, stewards, captains, escorts and any other persons associated with them are prohibited from accessing the competition zones on the "closed day" (November 27, 2025), prior to the start of the competition . Violation of this rule will result in exclusion from the Championship.

The Organization shall carry out random checks (searches) on board the vessels also during scouting period. This is to verify that no violations have been committed.

Area scouting days, boats may be inspected by police or other competent authorities.

The organizers recommend strict compliance with the fishing law and the regulations of Brazilian local/national governments. Any violation of the law may result in expulsion from the competition and confiscation of fishing equipment, as well as the application of administrative and economic fines.

Athletes who want to fish with underwater weapons outside the competition zones stipulated in the Regulation, and in waters of the State of Santa Catarina, they must contact the Santa Catarina Underwater Fishing Association for license processing at the corresponding local administration body by sending email to cbpds@cbpds.org.com.br

There is a prohibited area (Protected Zone) near the competition area, where fishing is not permitted (no fishing is allowed) as follows:

Monobuoy (Floating Oil Unloading Platform) This location is considered a national security area and cannot be approached within a radius of 500 meters, under penalty of fine and citation. Any athlete who is fishing within the estimated national security radius will be summarily disqualified from the event.

Coordinates (26°13.919'S / 48°25.179'W)

500m safety radius

You may not fish around any ship or vessels anchored near the test areas or in any other area outside the boundaries set out in these regulations.

During the course of the competition, the boat stewards are responsible for ensuring that competitors comply with the law.



### 11. THE COMPETITION

The Competition Director, together with the CMAS Technical Delegate, will direct the participants' boats to the middle of the competition area, as detailed with the captains at the meeting.

Once the participants have arrived, a count will be carried out and the start and end times of the Competition will be communicated. Likewise, the time margin to reach the meeting point at the end and go through a new arrival control will be notified.

For the match, all boats will assemble within the designated area, those competitors who are located outside this area may be reprimanded. The area will be designated and marked at the captains' meeting.

The end of the competition day will be announced by the Technical Delegate or the Tournament Director by means of audible and visual signals, as well as announcements over VHF maritime radios.

The organization's ship will have:

- Red flag Emergency alert, order for assistance.
- White flag and horn Start and End of the Competition.

At the end of the competition signal, competitors will stop fishing and return to their boats. Any catch not on the surface will not count..

PENALTY FOR DELAY IN TIME MARGINS (LIMITS): (regardless of the boat speed) in the event of mechanical failure, the athlete or team must immediately notify the Race Delegate to avoid being disqualified.

- Up to 5 minutes 2,000 points
- Each additional minute or fraction
   500 points

#### More than 15 minutes Disqualification

When maneuvering the boats, boatmen must be very careful not to disturb or interrupt other competitors, must stay away from them and, when necessary, must alert other boatmen in the vicinity of their competitor to avoid possible accidents or disturbances. The boatman is responsible for steering the boat and respecting the rules, both maritime and competition. He cannot deliver the necessary equipment on board to the athlete who is in the water, collect the catch and remove it from the harpoon (rod) if requested, only when the fish is on board with the diver inside the boat .

Harpoons may only be carried by athletes in the water, no one else may intervene. Boatmen may retrieve buoys when the competitor is on board the boat.

Boats may not intentionally disturb the fishing area by creating turbulence or circling to catch fish. Such conduct will be punished with a warning.

No boat may come close to any diver within a radius of 30 m (it is forbidden to navigate, transit or anchor any vessel within this distance of a diver, whether it is part of your team or not. Boats must leave athletes at the chosen fishing spot and move away from the spot, remaining at a safe distance of at least 30 m. To return to the boat, the athlete must swim towards the boat and not the boat paying the diver.

No diver should be more than 25 m away from his buoy and 50 m away from his/her test boat.

Athletes may not withdraw from the competition without notifying the Cmas Technical Delegate and the Competition Director. Once notified and authorized to withdraw, catches will be valid for the purposes of the Competition once they have been counted and the package containing the fish has been sealed by the race delegate.

#### **FISH QUOTAS**

All fish species will have a catch limit of 03 fish per athlete, per day, with the exception of the species below which will have a catch limit of 01 (one) fish per athlete, per day.

Piranjica (Chub) Sargo de Beico (BlackMargate) Enxada (Paru)

For athletes to earn the 1.000 points bonus for this species, they need to weight 1 Sargo de Beico, 1 Enxada and 1 Piranjica, all of them Valid.

#### **PENALTIES:**

- Penalties will be applied for catches weighing less than two thirds (2/3) of the minimum valid weight for each group of species. This penalty is equal to the number of points allocated by the minimum valid weight of a catch in the correspondent Group. (e.g. if the minimum weight for Sargo de Beiço is 2 kg, if the athlete catches a fish weighing 1.330 kg or less, he will be penalized with the number of points equal to minimum valid weight so 2000 points as a total penalty).
- In the event that the catch quota established for a species is exceeded, the two largest fish of the same species will be eliminated (Removed), and the quota bonus will not be granted. If two or more fish are exceeded, all catches of that species will be void.

#### **CLASSIFICATIONS:**

#### Score:

- One point per gram of each valid catch, plus the bonuses obtained, which can be per Valid Piece
   500 points, per Species 1000 points, for quota achieved 1000 points.
- The maximum score per weight that can be obtained for a piece is 12,500 points.
- Score will be made for each day.
- The total score for each athlete on each day will be a percentage taking as reference the score of the best athlete on that day, separately Men and Women.
- The athlete who obtains the best score in the day will have 100 points (100% of the points computed).
- The following participants will be allocated in percentage value, rounded to the third decimal place, according to the following formula:
  - Individual Score of Day (percent) = (Score of participant \* 100) / Best individual score of the Day
- In case of tie points, consider the number of valid pieces; if there is still a tie, consider the heaviest fish (the same criteria should be used for team ties).

#### SCORE CALCULATION

Athlete Score (PM) x 100

First place score (PP)

Formula:  $PM \times 100 / PP = Score$ .

The final individual classification will be determined by adding the percentage (%) scores of the two days.

The final Nation team ranking for Men / for Women will be determined by adding together the two-day percentage (%) scores of all competitors representing their Team.







- ✓ Water temperature 22 to 25 °C for the hygiene season.
- ✓ A wide variety of fish in different conditions, both in the foam and at depth, requiring anglers to have a good variety of skills and a large arsenal of strategies.

#### 5.3 - Test Area C (reserve): Vila da Glória Archipelago

- ✓ This is the sheltered area chosen as the Reserve area, 4 km from the beginning of the area, with a total length of 6.6 km.
- ✓ This place consists of 9 large islands and many plots;
- ✓ Fishing depths range from 0 to 13 m maximum;
- ✓ Water temperature 22 to 25 °C for the hygiene season.
- ✓ Many varieties of fish in different conditions both in the foam and at depth, but with less visibility conditions because they are inland waters.



#### 13. SAFETY PLAN

- The Organiser (LOC) undertakes to have means available in case of emergency and evacuation situations, under the supervision of the Technical and Safety Director. Therefore, the LOC undertakes to submit for approval by the CMAS Technical Delegate, no later than 6 weeks before the Championship, a Safety Plan that meets all the criteria in Annex 2 Safety List Criteria approved by CMAS, including an Evacuation and Emergency Protocol.
- Once approved by the CMAS Technical Delegate, the Safety Plan and Protocol will be communicated in detail at the Captains' Technical Meeting and the Stewards' Meeting.
- > **Support boats**: 6 support boats and a larger and more comfortable base boat will be made available to the CMAS committee regatta delegates.

On the support boats there will be 1 doctor, 2 firefighters, 2 Brazilian Navy personnel and a WC support team to assist the athletes.

- Other documents and authorizations requested, such as:
  - ✓ Testing regulations
  - ✓ Permission from the Brazilian Navy and Port Authority
  - ✓ Environmental license

They will be sent as soon as meetings with the relevant competent institutions are concluded.

The event organization is exempt from any additional costs for athletes, managers and committees attending the WC, such as air expenses, travel expenses or extras at the host hotel.

#### 15 SANCTIONS AND COMPLAINTS.

There are three types of sanctions:

- Warning
- Disqualification on the Day
- Disqualification in the Championship

The behaviors linked to all types of sanctions are:

#### **WARNING:**

- Late arrival at checkpoints provided by the organization, except for security reasons.
- Inappropriate and unsportsmanlike behavior towards other competitors, judges or any other person involved in the competition.
- Move more than 25 meters away from your official buoy.
- Carry or keep the harpoon loaded on the beach, on the buoy, on the fishing board (Buggy), on the support boat or anywhere else other than in the water.

- Using a main signal buoy that is different from the official buoy or that does not comply with the Rules.
- Failure to declare having completed (caught the total number permitted) the quota permitted for certain species of fish, as provided for in this Particular Regulation.
- During the competition period, fishing or being outside the authorized zone (limits) at a
  distance that could be considered accidental and unintentional.
- Obtaining assistance in retrieving the official buoy from any person on board the boat while the
  competitor is diving or on the surface of the water. There is no reason for a warning for
  receiving assistance while the competitor is on board his or her boat.
- To submit for weighing catches harpooned by another competitor, which remain on the bottom or surface with markings, wounds or catches which remain on the surface after the competition time has ended. This capture no will be valid and will not score points.
- Present the fish in a bag with or without water, different from the one provided by the
  organization. In addition to the warning, the fish will be weighed at the end of the weighing
  after removing the water when present.
- Violate any other provision of the rules not specifically provided for in this Special Regulation.

#### **DISQUALIFICATION ON THE DAY**

- Two warnings on the same day of competition will mean immediate disqualification on the day of the second warning.
- Carry the fish on your waist or store them somewhere other than the buoy or the official boat.
- Moving outside the boundaries of the competition area during competition time, to a distance that is considered intentional.
- Leaving the competition area before the end of the scheduled competition time or without
  passing through arrival control, without having obtained authorization from the CMAS
  Technical Delegate or the Competition Director, upon request from the Vessel Steward.
- Be in the competition area before the start of the competition or starting signal.
- Remaining in the water or off the boat after the official end time of the competition day, or ignoring the Boat Steward's warnings about doing so.
- To be dragged (towed) through the water by the boat under any circumstances except for emergency or safety reasons.
- Take the Freediver Recovery Vest without prior notification to the CMAS Technical Delegate or open its gas capsule.
- Freediver recovery BCD (even accidentally) or failing to present your gas capsule for inspection at the end of the day.
- Use an electric winch or any other electrical or mechanical method to retrieve lead or ballast from the bottom. Lead or ballast can only be retrieved by the human muscle power of the athlete, his assistant or the boat's driver. But not by two people simultaneously.
- Use a GPS/powered (Minn. Kota) that automatically keeps the boat in the same point (electric anchor).

#### TOTAL DISQUALIFICATION FROM THE CHAMPIONSHIP (OUTSIDE THE OFFICIAL CLASSIFICATION):

- Aggression towards other competitors, participants, judges or members of the organization, before or during the competition.
- Catching species prohibited by national legislation or violating any local fishing laws.
- Replace catches of regulated species or exchange them between athletes.
- Use any type of scuba diving or self-contained breathing apparatus.
- Dive or sail in the competition area, with or without a rifle, prior to the start time of the day on competition days.
- Return, discard or leave any type of fish at sea: invalid, prohibited or valid, of any weight.
- Fraud in the weight of catches.
- Use of energy heads, explosive tips, magnifying glasses and/or any device with explosive power or any system that is not powered by human physical effort.
- Use of any diving breathing system, or use of submarine propeller devices such as "torpedoes".
   During official competition time, as well as during the official zone visit or exploration period prior to the tournament.

#### **COMPLAINTS:**

- Each participating team has the right to present claims to the jury.
- Claims can only be signed and delivered by the team captain.
- Any complaint must be accompanied by a deposit or security, the amount of which will be set by CMAS.
- It must be presented in writing, in French, English or Spanish, to the Technical Delegate:
  - Before considering the development of the competition.
  - During weighing, this affects the weighing itself.
  - In relation to an error in the classification, the intention to complain must be made to the CMAS Delegate within 15 minutes of the publication of the classification and be accompanied by the deposit of the established deposit. (This measure has the immediate effect of delaying the formal medal ceremony.)
- From the moment of the intention to submit a claim, the claimant will have a period of 30 minutes to write and deliver his/her written report to the CMAS Technical Delegate. Otherwise, the claim will be considered null and void and the deposit will be forfeited.
- The complaint will be declared unacceptable if these conditions are not met.
- The deposit will be returned if the application is accepted and will remain with CMAS if it is not accepted.
